What You Need to Know	Next Steps
All of Washington’s public four-year college and universities are integrating flexibility into admissions processes to ease, to the extent possible, the disruption of COVID-19 for fall 2021 applicants. This includes: (1) SAT and ACT tests are not required to apply for fall 2021 freshman admission. Not submitting an SAT or ACT will not disadvantage an applicant in the review process. (2) Flexibility to waive high school course requirements required to minimum admission standards. (3) Continued use of multiple measures to review the whole student in the admissions process.	<ol style="list-style-type: none"> <li>1. Complete the FAFSA or WASFA</li> <li>2. ### Fall 2021 Admissions Deadlines

It is important to note that for many of the institutions these are “priority” deadlines. Priority deadlines are dates set by colleges and universities by which applications are given the most consideration must be received. Priority deadlines precede regular decision deadlines. Most of Washington’s public four-year college and universities continue to accept applications for fall 2021 beyond these initial deadlines.
